#### **Background:**

- 1. Government of Sindh constituted complaint Redressal Committee vide Notification No.SO(R&S)/8-110/2018-19/254 dated 30-12-2019 in terms of Rule 31(b) of Sindh Public Procurement Rule 2010.
- 2. The complaint Redressal Committee meeting was convened on the above complainant against the Technical Evaluation of Executive Engineer Small Dams Division Kohistan-I, Dadu letter No.XEN/SDO/Div: K-I/TC/227 dated 11-03-2020. List of participants attached.

### **Proceeding/ Decision:**

After going through the complaint of Mr. Ghulam Murtaza Enterprises, Government Contractor regarding illegal disqualification from Tender process and the relevant documents produced by the procuring agency, it was observed that Complainant has dis owned the complaint in writing and also his financial bid which earnest money is refunded to applicant on 14/05/2020 in light of facts the Complainant Redressal Committee (CRC) is of the unanimous opinion that the complaint is unvalid and carry no weight.

After going through the complaint of M/S Muhammad Alam Blaech and the documents produce by the procuring agency the Complainant Redressal Committee (CRC) is in the unanimous opinion that disqualification is based on solid grounds as already mentioned in the bid evaluation report (BER). It is further mention

that the complainant have refunded his financial bid i.e call deposit 19/05/2020 so it is observed that complaint stand un valid.
