**MINUTES OF THE COMPLAINT REDRESSAL COMMITTEE (CRC)
MEETING HELD UNDER THE CHAIRMANSHIP OF SUPERINTENDING ENGINEER
PROVINCIAL HIGHWAY CIRCLE SUKKUR (ON 01-06-2020)

The Meeting of Complaint Redressal Committee (CRC) was fixed on 24-03-2020, as per SPPRA Rule 31 to contemplate into complaints made by above complainants / Contractors, but due to lockdown of Government Offices, the meeting could not be held.

Meeting of the Committee re-scheduled on 14-05-2020, schedule was communicated vide this office letter No: BB(i)/ 421 Dated: 11.05.2020 and again it was rescheduled to 15.5.2020 but for the reasons best known both the members remained absent, hence the meeting could not be held and it has been rescheduled today i.e 1.6.2020.

It is necessary to mention here that **M/S Hamad Global Enterprises** through its proprietor **Syed Samiullah Shah** submitted statement in writing that his grievance has been resolved and he has nothing to say further in this respect and withdraw his application on 14.05.2020, but due to absence of the members meeting could not be held on 14.5.2020, therefore, the office presented application today, which has also been placed for discussion in the meeting.

Back Ground:- The Executive Engineer Provincial Highway Division Sukkur published NIT vide No: TC/G-55/ 210 dated: 25.02.2020 showing date of opening the Tenders as 16.03.2020 @ 2:20 PM.

(I) Brief facts of the complaint made by **M/S. Hamad Global Enterprises Government Contractor** through its proprietor Mr. Samiullah Shah are that when he put tenders in box, the Executive Engineer Provincial Highway Division Sukkur went and seated in bungalow and never returned back to office for opening of tenders from tender box.

(II) Brief facts of the complaint made by **M/S Shafquat Ali Katper and Sons** are that the working of Tender Clerk was controversial to SPPRA Rules and Regulations. He was collecting the Tenders in tender box in absence of Chairman and Members of Procurement Committee. He further alleged that he did not open tenders as per rules and by keeping the tender box in the room of XEN left the office by locking room from the outside.

(III) Brief facts of the complaint made by M/S. Fida Hussain & Brothers are similar to the complaint referred above (at serial No: II) that the working of Tender Clerk was controversial to SPPRA Rules and Regulations. He collected the tenders in Tender Box in absence of Chairman and Members of Procurement Committee. He further alleged that the Tenders were not opened as per rules. He further alleged that after keeping tender box in the room of XEN he locked the room from outside and left the office.

Proceedings:- The complaint matter M/S. Hamad Global Enterprises has been discussed in the meeting. It has been unanimously decided that since the proprietor Syed Samiullah Shah has voluntarily submitted statement in writing that his grievance has been resolved and he has nothing to say further in this respect and has withdrawn his complaint, therefore, said complaint has been dismissed as withdrawn.

Similarly M/S. Shafqat Ali Katpar and Sons Government Contractor and M/S. Fida Hussain and Brothers have also submitted statement in writing today, stating therein that their grievances have been resolved, therefore, they do not want to proceed with the complaint further and thereby they voluntarily withdraw from the complaint. The committee unanimously decided that since the grievance of the complainants has been resolved, therefore, their complaints stands dismissed as withdrawn.

Conclusion:- All the three complainants have voluntarily submitted their statements in writing, by which they withdrawn from the complaints, therefore, the committee unanimously decided that they have filed withdrawal statements voluntarily, therefore, all the three complaints have been dismissed as withdrawn.


