### BEFORE COMPLAINT REDRESSAL COMMITTEE UNDER RULE NO: 31 OF SPPRA RULES 2010

### **FACTS AND BACKGROUNDS:-**

A meeting of Complaint Redressal Committee was held on 25-06-2020 at 12:30 PM in office of the Superintending Engineer, Provincial Highway Circle, Hyderabad / Chairman Compliant Redressal Committee in connection with complaints made by the following contractors against Executive Engineer, Provincial Coastal Highways Division Hyderabad.

i. M/S. Sindh Builders

ii. M/S. S& Sons

iii. M/S. F.B Enterprises

iv. M/s. TEBA International Contracting

v. M/S. Wajid Ali Khan

vi. M/S. Abdul Malik Khan

vii. M/s. Ghulam Murtaza Enterprises

The meeting started with the name of Almighty Allah. The chair welcomed to all the participants and informed that the basic purpose of the meeting was to go through allegations leveled by the complainants in connection with tenders invited by Executive Engineer, Provincial Coastal Highways Division Hyderabad vide NIT No. TC/G-55/CHD/247 dated. 21-02-2020 and No. TC/G-55/CHD/256 dated. 25-02-2020 and reply of the Executive Engineer concerned in his deference duly supported with relevant documents.

### I. COMPLAINT MADE BY M/S. SINDH BUILDERS

The complainant has alleged through his complaint dated 07-06-2020 that they had offered the bid amounting to Rs. 42,494,651/- for the work namely "Reconditioning of Link Road from National Highway Thatta City to Dargah Shah Murad Sheerazi upto Jugshahi" invited vide NIT No. TC/G-55/CHD/256 dated. 25-02-2020 and they were declared the lowest bidder but the Bid Evaluation Report has been manipulated.

The Executive Engineer replied that the allegations leveled are baseless as the sealed Bid was not received within due date and time of opening the bids. Besides this, the complainant has also withdrawn from his complaint on 23-06-2020 (Annexure-A).

### **DECISION**

The committee unanimously decided that the complainant has already withdrawn hence the complaint was dismissed.

### II. <u>COMPLAINT MADE BY M/S. S& SONS</u>

M/s. S & Sons, Government Contractor has alleged that illegal Evaluation Report pertaining to bids received against NIT NO. TC/G-55/CHD/247 dated 21-02-2020 has been hoisted by the Executive Engineer Provincial Coastal Highway Division Hyderabad.

The Executive Engineer Provincial Coastal Highway Division Hyderabad informed that the sealed bid submitted by the complainant was not received on 16-03-2020 but actually it was received on 17-03-2020 through TCS (Annexure-B), whereas, the bids were already opened on 16-03-2020. On verification of TCS receipt, the reply of the Executive Engineer Provincial Coastal Highway Division Hyderabad was convincing and the complainant also couldn't produce any further proof. Moreover, the complainant also withdrawn from their complaint vide No. 1771 dated 25-06-2020 (Annexure-C).

### **DECISION**

While going through reply of the Executive Engineer Provincial Coastal Highway Division Hyderabad and letter given by the complainant to withdraw from the complaint, it was decided that the complaint is dismissed.

#### III. COMPLAINT MADE BY M/S, F.B ENTERPRISES

The complainant has alleged that Bid Evaluation Report hoisted on SPPRA's website on 19-05-2020 bearing ID No. 00592-19-0004-1 to 6 are based on fabricated & fake figures. Moreover, on the date of opening only Chairman Procurement Committee was present in the office.

The Executive Engineer Provincial Coastal Highway Division Hyderabad replied that the allegations were baseless, as the tenders were opened on the fixed date and time by the Procurement Committee in presence of the contractors. In this connection, attendance sheet was also produced by the Executive Engineer (Annexure-D). Besides this, the complainant has also admitted vide letter dated 25-06-2020 (Annexure-E) that their bid was really not received to procuring agency within fixed date and time of the opening of the bids.

### **DECISION**

On verification of the record, it was found that the bids were opened on the fixed date and time. Moreover, the complainant has also admitted that bid sent by him were not received within due date and time. Hence, the complaint was dismissed.

### IV. COMPLAINT MADE BY M/S. TEBA INTERNATIONAL CONTRACTING

M/s. TEBA International contracting alleged in their complaint that Executive Engineer Provincial Coastal Highway Division Hyderabad made mis-procurement and committed irregularities in tendering process pertaining to NIT No. TC/G-55/CHD/247 dated 21-02-2020. But during hearing, the complainant produced application wherein he stated that he has no grievances and withdrawn from the complaint (Annexure-F).

The Executive Engineer Provincial Coastal Highway Division Hyderabad replied that allegations leveled against him were baseless and procurement was entirely according to SPPRA Rules.

#### DECISION

The committee decided that the complainant has withdrawn from his complaint. Hence, the complaint was dismissed.

### V. COMPLAINT MADE BY M/S. WAJID ALI KHAN CONTRACTOR

The complainant has alleged that he had offered the bid against the work mentioned at S. No. 4 & 9 in NIT No. TC-G-55/CHD/247 dated. 21-02-2020, wherein, he was lowest in the both bids but as per Bid hoisted on SPPRA website, the lowest bidder was declared another contractor. In addition to this, their bid against the work at S. No. 6 of NIT No: TC/G-55/CHD/256 dated 25-02-2020 was the lowest but bids have not been hoisted upto 04-06-2020.

In this connection, Executive Engineer Provincial Coastal Highway Division Hyderabad replied that no bid of M/s. Wajid Ali Khan was received within due date and time fixed for opening of the Bids. The complainant also failed to appear before the committee on 25-06-2020 despite issuance of letter to them.

### **DECISION**

On verification of the documents produced by the Executive Engineer, it was found that the complainant was failed to produce any authentic proof for submitting the bids within due date and time on one hand and on other hand failed to attend CRC meeting. Hence, the complaint was dismissed.

### VI. COMPLAINT MADE BY M/S. ABDUL MALIK KHAN

The complainant has alleged that he had offered bid amounting to Rs. 17,947,393/-for the work mentioned at S. No. 1 of NIT No. TC/G-55/CHD/256 dated 25-02-2020 but as per Bid Evaluation Report hoisted on SPPRA's website, the lowest bidder has been recommended M/s. Haji Habibullah Khan.

In this connection, the Executive Engineer Provincial Coastal Highway Division Hyderabad replied that no Bid of M/s. Abdul Malik Khan was received within due date and time and allegation of the complainant is baseless.

On verification of the documents produced by the Executive Engineer, it was found that the complainant was failed to produce any authentic proof for submitting the bids within due date and time fixed for opening of the bids. Moreover, the complainant also didn't attend the CRC meeting deliberating to produce any further proof.

### **DECISION**

The committee decided that the complainant has been failed to produce any authentic proof or attend the meeting hence, the complaint was dismissed.

### COMPLAINT MADE BY M/S. GHULAM MURTAZA ENTERPRISES VII.

The complainant has alleged that members of procurement committee were not present on the date of opening and also expressed his fear that Executive Engineer intends to award the contracts to political influential contractors in violation of SPPRA Rules.

The Executive Engineer, Provincial Coastal Highways Division Hyderabad replied that the allegations are baseless. The bids were opened on the fixed date and time of opening. Moreover, the complainant has been declared lowest in one Bid Evaluation Report (Annexure-G). The complainant agreed that he has been declared lowest in one contract and expressed his satisfaction regarding Procurement Process.

### **DECISION**

The reply of the Executive Engineer, Provincial Coastal Highways Division Hyderabad duly supported with documents was satisfactory. Hence, the complaint was dismissed.

The meeting ended with a vote of thanks from and to the chair.
