MINUTES OF THE COMPLAINT REDRESSAL COMMITTEE
(CRC) MEETING HELD ON 19.06.2020 TO HEAR THE
COMPLAINTS/GRIEVANCES AGAINST MR. SHARAFUDDIN BHANBHAN,
EXECUTIVE ENGINEER EAST DIVISION, KHAIRPUR FOR THE WORK OF
ROAD BRIDGE OVER MIRWAH CANAL AT RD 33, CONSTRUCTION OF
GRILL OVER RETAINING WALL ALONG MIRWAH CANAL FROM RD 69
TO RD 70+100 BOTH SIDES.

Background:-

3. Government of Sindh constituted Complaint Redressal Committee vide Notification No.SO(R&S)8-110/2018-19/254, dated 30.12.2019 in terms of Rule 31(b) of Sindh Public Procurement Rule 2010.
4. The Complaint Redressal Committee meeting was convened for hearing of grievances / complaints of above cited / mentioned bidder/ complainant in connection with the NIT invited by Executive Engineer, East Divisions Khairpur vide No.TC/G-55/330 dated:24.02.2020.

Proceeding / Decision:-

After hearing the grievances of the complainants and going through the relevant letters/documents produced by Procuring Agency, Complaint Redressal Committee (CRC) observed that the said NIT No. TC/G-55/330 Dated the 24th Feb, 2020 was scheduled to be opened on 18-03-2020 & the 2nd attempt was on 03-04-2020. Accordingly the bid was opened in first attempt i.e 18-03-2020 & Work Order was issued on 30-03-2020. Now as per the Executive Engineer, East Division, 15% of the work has been executed at site. Moreover, this office received the said complaints in the month of June.

Keeping in view the above, the Committee is of the unanimous opinion that the complaints are time barred as the proceeding of SPP Rule. 50 has been completed well before receiving the complaints. Moreover, looking at the quantum of work executed, cancelling the tender process at this stage will have legal repercussions. The Committee, therefore declares the procurement process as Valid.
