

The chair welcomed to all the participants and informed that the basic purpose of the meeting was to go through allegations leveled by Ghulam Murtaza Enterprises, Government Contractor in connection with tenders invited by the Executive Engineer, Provincial Highways Division Mirpurkhas vide NIT No. TC/G-55/108 dated 31-01-2020 and reply of the Executive Engineer concerned in his defence duly supported with relevant documents.

The complainant has alleged through his complaint dated 20-03-2020 that they had submitted their bid through TCS for the work mentioned at S. No. 03 of NIT No. TC/G-55/108 dated 31-01-2020 and the sealed envelope was delivered on 20-02-2020 but the same was not entertained.


The complainant has further stated in his same complaint that he visited office of the Executive Engineer, Provincial Highways Division Mirpurkhas on 09-03-2020 to participate in opening process of the Bids but the bids were not opened.

The Executive Engineer, Provincial Highways Division Mirpurkhas replied that the bids were opened on 09-03-2020 by the procurement committee in presence of the contractors and attendance sheet of the contractors (Annexure-A) and Procurement Committee Members (Annexure-B) was also produced. The bids duly signed by the complainant were also produced and his name was also mentioned in minutes of Bid Opening Meeting (Annexure-C).


DECISION


The meeting ended with a vote of thanks from and to the chair.
