MINUTES OF THE MEETING OF COMPLAINT REDRESSAL COMMITTEE HELD ON 02.07.2020.

The Complaint Redressal Committee (CRC) has held its follow-up meeting today on 02-07-2020 at 4.00 pm in the Directorate of Food, which have been attended by all members including Deputy Director Food, Hyderabad.

2. The meeting started with recitation of verses from the Holy Quran and later the cases of two aggrieved firms M/S Mehran Transport Co. and M/s Pearl Enterprises have been examined on merit.


3. The CRC is of the opinion that:


- (i) The Complaint of M/S Mehran Transport Co. moved as against the decision of CRC date 18-05-2020, is not maintainable under Rule-32 of SPPRA, Rule-2010 (amended upto date).
- (ii) As for as M/S Pearl Enterprises is concerned, its plea is rejected on the following ground:


The CRC also finds contradiction in two documents provided by the applicant; the performance certificate provided by the applicant indicates its (05) years work performance with Dewan Cement Ltd. Whereas the registration certificate issued by Sindh Revenue Board (SRB) shows that the firm got itself registered from SRB on 08-06-2020 with effectiveness from 05-12-2019, therefore making it ineligible for competition.

4. In view of the reasons stated above, the appellant's plea does not carry any weight in the eyes of Law and Rules and is therefore to be rejected. The CRC therefore, with the consensus rejects the appeal/representation and upholds the tender proceedings carried out by Deputy Director, Hyderabad Food Region.
