SUBJECT: MEETING OF COMPLAINT REDRESSAL COMMITTEE (CRC).

WHEREAS: M/s Ghulam Murtaza Enterprises, M/s MBK Construction Co Private Limited and M/s F.B Enterprises made a complaint against the Executive Engineer Begari Sindh Feeder Division Kashmore regarding Tenders advertised under NIT No. TC/G-55/1124 Dated: 06.12.2021.

Crux of Complaint.

- (i) Complaints visited office of the Executive Engineer Begari Sindh Feeder Division Kashmore on 23.12.2021 to receive tender form but they refused issue the same.
- (ii) Complaints visited office of the Executive Engineer Begari Sindh Feeder Division Kashmore to submit tender on 28.12.2021, but neither Chairman nor the members of Procurement Committee were present.
- (iii) The Executive Engineer Begari Sindh Feeder Division Kashmore issued corrigendum vide letter No. TC/G-55/1170 Dated: 24.12.2021 and postponed tendering process for 2nd attempt which is violation of Rule 4 of SPPRA Rules.

WHEREAS: A meeting of CRC was called on vide this office letter No. SAC/G-2(b)/03 Dated: 03.01.2022. Wherein Executive Engineer Begari Sindh Feeder Division Kashmore and the other Procurement Committee denied the charges as aforesaid. The Executive Engineer Begari Sindh Feeder Division Kashmore further informed that Single Stage – Two Envelope tender was uploaded on the official web site of SPPRA besides on the print media as well, so that every interested contractor can draw tender form etc. Therefore to blame that they did not received tender form is un-justified even other wise they did not attend Divisional Officer.

Executive Engineer Begari Sindh Feeder Division Kashmore further said that Technical Proposals were opened on due date i-e 28th December 2021, wherein about 20 Contractors took part in the competition. Regarding the question of issuance of corrigendum, Executive Engineer concerned denied that his office never issued any corrigendum.


