

**MINUTES OF THE IRRIGATION DEPARTMENT COMPLAINT
REDRESSAL COMMITTEE (CRC), MEETING HELD ON 16.06.2020 TO
HEAR THE COMPLAINTS/GRIEVANCES AGAINST MR. ABDUL
SATTAR SARIO, EXECUTIVE ENGINEER, CHOTIARI RESERVOIR (1)
DIVISION, SANGHAR REGARDING INVITATION OF BIDS ON THE
BASIS OF OLD/EXPIRED PRE-QUALIFICATION OF CONTRACTORS.**

Background:-

1. Government of Sindh constituted Complaint Redressal Committee vide Notification No.SO(R&S)8-110/2018-19/254, dated 30.12.2019 in terms of Rule 31(b) of Sindh Public Procurement Rule 2010.
2. The Complaint Redressal Committee meeting was convened for hearing of grievances / complaints of above cited / mentioned bidder/ complainant in connection with the NIT invited by Executive Engineer, Chotiari Reservoir (1) Division, Sangharvide No.TC/G-55/CRDS129/81 dated: 10.03.2020.

Proceeding / Decision:-

After hearing the grievances of the complainants, going through the relevant record / documents produced by the Procuring Agency & referring the relevant rules / regulations of SPP Rules-2010, Complaint Redressal Committee (CRC) observed that the said NIT No. TC/G-55/CRDS/129 Dated the 10th March, 2020 was scheduled to be opened on 31-03-2020. It was apprised by the Procuring Agency that the bids are received from the Pre-Qualified bidders & the same were opened on 31-03-2020. The Procuring Agency further informed that Bid Evaluation Report(BER) was uploaded on SPPRA Website on 03rd April, 2020 & Work Order was issued on 08th April, 2020. On a query from the Chair, the Procuring Agency explained that 15% of work has been executed at site till to date. Moreover, the instant complaints were received to the undersigned in the month of June, 2020.

Keeping in view the above, the Committee is of the unanimous opinion that the complaints are time barred as the proceeding of SPP Rule-50 has been completed well before receiving the complaints. Moreover, looking at the quantum of work executed, cancelling the tender process at this stage will have legal repercussions. The Committee, therefore declares the procurement process as Valid.
