Opening the discussion, Chief Engineer PHE Region Hyderabad / Chairman CRC pointed out the complaint in respect of NIT No.TC/PHE/2165/2020 dated:20.05.2020 has been received from M/s WSKB & Co. wherein they have alleged that despite fact that they submitted bidding documents their participation in the process has not been shown. The Chairman asked Executive Engineer PHE Division Thatta to clarify the position Taking part in discussion XEN Thatta briefed committee as under.-

Tender documents as stated in complaint were not received Mr.G.H Jillani who is stated to have received documents has denied and has contended that according to set office procedure he is not supposed to receive / collect the DAK and perhaps this misconception is created due to the reason that several offices of other organizations are also housed in the vicinity of PHED office Thatta and probably someone else had received those documents which did not reach in the office of XEN PHE Thatta as such Company / Firm was not made part of bidding process. The other allegations are immaterial and do not merit consideration.
