COMPLAINT:-

That M/S Asif Raza contractor files this complaint No. ARC/262 of 2020 dated: 28-06-2020 received by the Complaint Redressal Committee from Assistant Director Legal-II of SPPRA, Karachi and stated that he is registered government contractor and taking government contracts since 2015 and Town Committee Ghouspur, Chairman Procurement Committee Municipal Engineer, MC Kandhkot and members uploaded NIT ID TO1687-19-0001 NIT No. TC/GHP/81/2020 dated:- 05th June 2020 for inviting offers/bids for different work and fixing 25th June 2020 upto 12:00 noon as last date of issuing tender forms and dropping was same day 25th June 2020 up to 01:00 PM and opening process was also same day 25th June 2020 at 02:00 PM in the presence of Committee members and bidders/contractors or their authorized Post ison dosus representative.

Further stated that complete downloaded tender forms along with company documents of various works filled up with original call deposit and tender fee in shape of pay order in sealed envelope and visited my authorized representative in the office of TC Ghouspur dated:- 25th June 2020 at 11:05 AM in order to drop tender documents in tender box, but on 25th June 2020, their authorized representative was in the office of TC Ghouspur during office time non one member of Chairman Procurement Committee of this NIT was not available at office there and office clerk informed that Chairman of Procurement Committee has decided that due to uncomplete procurement committee, the dropping and opening process will at next time and all the contractors will be informed. However notice for postpone and cancellation of dropping process was not posted in notice board.

That it has been observed that Procurement Committee and members wants to start dropping and opening process in secret manner in order to award the work to his controller and giving all the works in their favourable contractors which is violation of SPPRA rules.

Therefore, complainant request to direct the Chairman Procurement Committee and Members to issue Corrigendum for next date of this NIT at SPPRA web and at notice board by informing all the contractors and also direct him to follow SPPRA Rules, hence this complaint is for intervention.

PROCEEDINGS

The matter was taken up with complainant by the CRC of Town Committee Ghouspur advising to appear before the CRC on Monday 13th July 2020 along with documentary proof vide this office letter bearing No. TC/GHP/91/2020 dated:- 10th July 2020 but the complainant did not appear. However the complainant was again requested to appear on 17th July 2020 along with documentary proof vide this office letter No.TC/GHP/92/2020 dated:- 15th July 2020 to redress the grievances, but the complainant did not complied with through the above letters were sent through TCS courier No. CN 5564730493 on 11th July 2020, and Leopards courier No. 551397331 on 15th July 2020 and last one also through Whatsapp on 16th July 2020.

From perusal of video recording recorded on 25th June 2020 the complainant was not present although other bidders who were participated in the dropping of the tender forms on 25th June 2020 at 01:00 PM and available during opening of bids on 25th June 2020 at 02:00 PM (Photographs attached).

CONCLUSION

In view of above facts and grounds it is transpired that the complainant was given 02 chances but failed to produce the documentary proof on the both days i.e 13th July 2020 and 17th July 2020 of the instant, and the non-attendance in the tender dropping and opening process before the procurement committee, hence the complaint stands disposed of accordingly.
