### Background:-

- Government of Sindh constituted Complaint Redressal Committee vide Notification No.SO(R&S)8-110/2018-19/254, dated 30.12.2019 in terms of Rule 31(b) of Sindh Public Procurement Rule 2010.
- The Complaint Redressal Committee meeting was convened for hearing of grievances / complaints of above cited / mentioned bidder/ complainant in connection with the NIT invited by Executive Engineer, West Divisions Khairpur vide No.TC/G-55/1705 dated:13.05.2020.

## Proceeding / Decision:-

After hearing the grievances of the complainants and going through the relevant letters/documents produced by Procuring Agency, Complaint Redressal Committee (CRC) observed that the said NIT No. TC/G-55/1705 Dated the 13<sup>th</sup> May, 2020 for which the Technical Proposal was opened on 05<sup>th</sup> June, 2020 & Financial Bid on 25<sup>th</sup> June, 2020. Accordingly the Work Order was issued on 02-07-2020. The complainants/aggrieved bidders argued that the PA & Procurement Committee have intentionally disqualified them to benefit their blue eyed contractor. In response to the allegation, the Committee scrutinized the Evaluation Criteria & the score assigned to the bidders & found no any major anomaly or deviation.

Keeping in view the above, the Committee is of the unanimous opinion that the PA followed the procurement process as per SPP Rules. Moreover, the PA has completed the proceeding of SPP Rule-50. The Committee, therefore declares the procurement process as Valid.
