The chairman welcomed all the participants and subsequently informed the forum about the complaints made by above named Contractors/Complainants regarding procurement process related to NIT No. XEN(EWD)/TC/1438 dated 04.11.2021 issued by Procuring Agency/ Executive Engineer, Education

Previously, a CRC meeting was held on 30.12.2021 at 1:00 p.m in the office of undersigned. All the participants as mentioned above as well as Mr. Abdul Jabbar Jeho the representative of the complainant M/S Abdul Hafeez Kolachi attended the meeting on the scheduled date and time. In the said meeting, the complainant narrated that he had approached the Executive Engineer, Education Works Division Shikarpur to participate in the tenders fixed to be opened on 14-12-2021, but the XEN concerned denied to conduct fair and transparent open competition in tenders and did not place the Tender Box nor conducted

During the course of previous CRC meeting held on 30.12.2021 at 1:00 p.m, the Procuring Agency / Executive Engineer, Education Works Division Shikarpur briefed in his statement that the tenders of the instant NIT were opened on the scheduled date i.e 14-121-2021 in the presence of all interested bidders by observing all the codal formalities as required under SPP Rules, 2010 (Amended 2019), but the Complainant M/S Abdul Hafeez Kolachi did not participate in the bidding process. The XEN concerned strongly denied the allegations leveled by the complainant in his complaint dated 14-12-2021.

At the time of previous CRC meeting on 30.12.2021, the Chairman CRC asked the representative of M/S Abdul Hafeez Kolachi to produce the documentary evidences i.e Call Deposit, Pay Order, Valid Registration with PEC/FBR/SRB, but he failed to produce the same and approached the chairman to give him chance to bring the original documents in the next meeting. The next meeting was fixed

M/S Jahangeer Khan Solangi, and M/S Proud Build Construction, Government Contractors/ Complainants also failed to attend the CRC meeting fixed on 11-02-2022 at 3:00 p.m.

CRC forum verified all documentary evidences presented by the Procuring Agency/ Executive Engineer, Education Works Division, Shikapur and observed no any violation of SPP Rules 2010 (Amended 2019) on the part of procuring agency in connection with procurement process of the instant NIT.
