

BEFORE COMPLAINT REDRESSAL COMMITTEE UNDER RULE NO: 31 OF SPPRA RULES 2010

FACTS AND BACKGROUNDS:-

A meeting of Complaint Redressal Committee was held on 08-07-2020 at 11:30 AM in office of the Superintending Engineer, Provincial Highway Circle, Mirpurkhas / Chairman Compliant Redressal Committee in connection with complaints made by M/s. F.B Enterprises & M/s. Hussain Enterprises against Executive Engineer, Provincial Highways Division Mirpurkhas.

The meeting started with the name of Almighty Allah. The chair welcomed to all the participants and informed that the basic purpose of the meeting was to go through allegations leveled by the following, Government Contractors in connection with tenders invited for different works by the Executive Engineer, Provincial Highways Division Mirpurkhas vide NIT No. TC/G-55/95 dated 24-01-2020 & No/TC/G-55/216, dated 25-02-2020, and reply of the Executive Engineer concerned in his defence duly supported with relevant documents.

1. **F. B ENTERPRISES GOVERNMENT CONTRACTOR:**

The complainant has alleged through his complaint dated 12-06-2020 that they had applied for the bids invited for different works through NIT No. TC/G-55/95 dated 24-01-2020 and TC/G-55/216 dated 25-02-2020 by the Executive Engineer Provincial Highways Division Mirpurkhas but the result of bids opened on 18-02-2020 was not announced through Bid Evaluation Report and they were feared that their bids may be changed. Moreover no exercise of opening the bids in respect of NIT No. TC/G-55/216 dated 25-02-2020 was made on 16-03-2020.

The Executive Engineer Provincial Highways Division Mirpurkhas replied that bids pertaining to both NITs were opened on the fixed date and time by the Procurement Committee in presence of the contractors and Bid Evaluation Reports were also hoisted, but the complainant couldn't produce the required documents as per eligibility criteria.

DECISION

On verification of the documents and reply given by the Executive Engineer Provincial Highways Division Mirpurkhas, it was decided that the complaint was required to produce complete documents hence the compliant was rejected.

2. **M/S. HUSSAIN ENTERPRISES:**

The above named contractor has complained that he sent his bids invited Executive Engineer Provincial Highways Division Mirpurkhas vide NIT No. TC/G-55/216 dated 25-02-2020 through TCS but on one hand neither any process of opening was held on the fixed date and time and on other hand he has been disqualified as verified from Bid Evaluation Report hoisted on SPPRA's website.


The Executive Engineer Provincial Highways Division Mirpurkhas replied that the bids were opened on the fixed date and time by the Procurement Committee in presence of the contractors and their attendance sheet was also produced for verification. He further informed that as per eligibility criteria all the relevant documents were required to be produced but the complainant couldn't fulfill such requirement.


DECISION

On verification of attendance sheet and Bid Evaluation Report, it was observed that procurement process was made according to SPPRA Rules and it was responsibility of the complainant to produce complete documents in the light of eligibility criteria. Hence the complaint was unanimously rejected.
