The chair welcomed to all the participants and informed that the basic purpose of the meeting was to go through allegations leveled by Lekhraj Shivani, Government Contractor in connection with tenders invited by the Executive Engineer, Provincial Highways Division Thar @ Mithi vide NIT No. TC/G-55/356 dated 18-05-2020 and reply of the Executive Engineer concerned in his defence duly supported with relevant documents.

### **COMPLAINANTS VERSION:-**

1. The complainant was of the view that, he interpreted that total amount of all works carried out during past three year should be of same cost or above having same specification nature, not the three works, each having same cost or above having same specification and nature.
2. The compliant informed that he did not receive letter through mail but he was informed in phone, and I got copy on whatsapp.

13. The compliant stated that outward no on letter is 17-06-2020 & BER was hosted on 22-07-2020.

#### **PROCURING AGENCY'S VERSIONS.**

1. Mr. Ghulam Hussain Khatti, Executive Engineer Provincial Highway Division Thar @ Mithi at there being Chairman of Procuring Agency justified that evaluation criteria (II) vividly says "At least three works of same specification and nature of equivalent or more cost completed during past three years in desert area, duly supported with completion certificate" which clearly specify that three works; each having equivalent or more cost with same specification and nature, but the complainant failed to produce certificate of three works of equivalent or more cost.
2. The Executive Engineer replied that the complainant lives in the same city i.e Mithi letter was sent through ordinary mail, informed on phone and copy was sent on whatsapp.
3. Executive Engineer responded that outward no, dated 17-06-2020 was a mistake actual date is 17-07-2020 which he justified by producing outward register and office copy of letter.


#### **DECISION OF CRC**


Both parties were given full time to clarify their point of view after detailed discussion and deliberations the CRC is of opinion that three works, each having equivalent cost or more having same specification & nature completed during past three years is a integral part of eligibility criteria, which the contractor failed to justify / prove.

The decision of procurement committee of disqualifying the complainant is as per SPPRA rules & regulations & is being upheld.
