MINUTES OF MEETING OF COMPLAINT REDRESSAL COMMITTEE HELD ON 07.08.2020 TO HEAR THE GRIEVANCES AGAINST XEN KALRI BAGHAR DIVISION, NIT NO. TC/G-148/525 DATED: 16-07-2020.

A meeting of Complaint Redressal Committee (CRC)constituted vide Irrigation Department Notification No.SO(RS)8-110/218-19 Dated 30th November, 2019 was held under the chairmanship of Director Design in Sindh, Irrigation Department Hyderabad @ 28-A, Civil Lines, Hyderabad on 07th August 2020 @ 11.30 a.m. in connection with complaint lodged by M/s Haji Habibullah Khan regarding procurement of ADP scheme namely "CC Lining of Ghar Massan Minor from RD 0.00 to RD 24.280" invited by Executive Engineer Kalri Baghar Irrigation Division vide NIT No. TC/G-148/525 Dated: 25-07-2020.

The CRC formally examined the grievances/complaints of M/s Haji Habibullah Khan vide his complaints Dated: 24-07-2020 in terms of Rule-31 of SPP Rules-2010 (amended up to date).

The chair briefed the participants about the agenda of the meeting.

Meeting started with recitation of verse of Holy Quran. Chair welcomed the participants and commenced the proceedings.

The Procuring Agency apprised the participants that:

- 1. The instant NIT was invited from the bidders/firms registered with PEC having appropriate specialized codes and eligibility criteria given in NIT & bidding Document in accordance with SPP Rules-2010 (amended up to date) SPPRA Procurement Regulations (WORKS) under Single Stage Two Envelope procedure with date of opening of Technical Proposals/bids as 11-08-2020.
- The NIT was well advertised in leading Newspapers and SPPRA websites @ ID No.T00933-20-0001.

- 3. Since the last date of submission & opening of Technical proposals is 11-08-2020, therefore, the number of bidders is not clear as yet.
- 4. The technical bids/proposals will publicly be opened on 11.08.2020.

The Complaint Redressal Committee heard the bidder/complainant as under:

Mr. Aamir Aftab, authorized representative of the firm, confirmed about his complaint lodged by him. He was heard about the contents of his complaint along with replies of Procurement Committee as under:

• The Complainant has so far neither purchased the Tender Documents nor shown any proof of CDR in favour of Executive Engineer Kalri Baghar Division.

CONCLUSION/DECISION:

• The complaint of the bidder/complainant is not maintainable as he has neither purchased the Tender Documents nor shown any proof of CDR in favour of Executive Engineer Kalri Baghar Division, however, the Committee examined all the contents of complaint & concluded that the procurement regime is in accordance with SPP Rules-2010 (amended up to date) SPPRA Procurement Regulations (WORKS). Therefore the CRC unanimously reject the complaint lodged by M/S Haji Habibullah Khan taking into account the contentions of the complainant & procuring agency in accordance with SPP Rules-2010 (amended up to date). However, this Committee allows the bidder for any of his grievances after opening of Technical Bids, if he applies for.
