MINUTES OF THE COMPLAINT REDRESSAL COMMITTEE (CRC) MEETING HELD UNDER THE CHAIRMANSHIP OF SUPERINTENDING ENIGNEER PROVINCIAL HIGHWAY CIRCLE SUKKUR ON 15-07-2020. (LIST OF PARTICIPANTS ATTACHED)

Meeting of Complaint Redressal Committee (CRC) held on 15-07-2020, as per SPPRA Rule 31 to hear complaint made by M/S Abra Construction Company. The meeting was convened vide letter No.BB(i)/671/2020 dated 10.7.2020, the Complainant could not attended the CRC Meeting though he has been requested vide this office letter No. mention above.

It is pertinent to mention here that on same complaint the meeting was scheduled to be held on 7.7.2020 vide letter No. BB(i)/618/2020 dated 2.7.2020, but the Chairman proceeded to casual leave, therefore, meeting was rescheduled on 9.7.2020. Such information was communicated to all the concerned vide office letter. No. BB(i)/637/2020 dated 7.7.2020 but both the Members remained absent without any intimation, therefore, the meeting was again adjourned to 15.7.2020. All the concerned were intimated accordingly through office letter No. BB(i)/671/2020 dated 10.7.2020.

Back Ground:- The sealed bids were called through NIT No.TC/G-55/211 of 2020 dated 12.5.2020 from the interested bidders for the works mentioned in the same.

M/S Abra Construction Company filed complained that the firm representative downloaded the bidding documents from the website, filled the rates and attached original Pay order of the 5% required earnest money and D.R fees and proper sealed in envelope with complete required documents and reached the office for dropping in the box for proper transparent/ healthy competition. He further alleged that the Executive Engineer Machinery Maintenance Division Hyderabad Digri @ Kotdiji, who failed to Bring/Keep Tender Box and to complete the Procurement Committee Quorum. He further alleged that no any dropping, opening and competition was made actually.

Executive Engineer Machinery Maintenance Division (Hyd) Digri @ Kotdiji, vide his letter No:TC/G-55/338, Dated:10-07-2020, in the comments has denied the

allegations leveled against him. He further stated that Tenders filled by the complainant bear over writing as well as contain high rates, therefore, he was not entitled for consideration, hence he with malafide intention has filed complaint before the CRC. He further reported that whole the procurement proceedings have been made fairly, by the Procurement Committee and no any illegality or irregularity has been made in the bidding process.

Conclusion:- The complainant has been confronted on the report submitted by the Executive Engineer, to which he is unable to explain about the over writing made in the Tenders. The rates mentioned in the tenders appear to be highest, hence rightly the complainant has not been considered by the procurement committee.

Looking to the above facts and circumstances, the Complaint Redressal Committee is of the unanimous view that since the tenders filled by the complainant show over writing as well as highest rates, hence complainant has made this complaint with some ulterior motives. The complaint has been invited to attend the CRC meeting but, he has failed to attend the same which shows he is not interested to follow the complaint. The Complaint therefore, does not merit any consideration, hence the CRC has unanimously decided that the complaint does not merit any consideration, which stands dismissed.
