- 2. Tender will be opened in the presence of such tenderers, who wish to be present there.
- 3. Tender should be legible filled in ink total should be correctly made.
- 4 Canvassing by tenderers / and or his agent shall made the tender liable to cancellation.
- No alteration will be allowed to be made in the tender, condition of this contract, in the specifications or in the schedule subsequent to the opening of the tenders.
- Tender are warned to exercise great care in entering their rates in the schedule annexed to their tender. No excuse that mistakes have been made no any request for rates to be corrected will be entertained after tenders have been received. Decision on the tender will be in accordance with the rates entered in the tender schedule.
- 7 Any alteration or over writing in the rates shall render the tender liable to rejection. Correction rates must be made by striking out the original entries duly initialed.
- 8 Unless otherwise stated all the materials are to be as per basic approved sample kept in above institutions or where no basic / approved sample is kept where specification is laid down supplied should strictly confirm to the same.
