Issuance of Tender Documents: Blank tender forms can be collected from the office of Procurement Officer UCG Project Thar, upto 26-02-2015, during office hours after depositing the tender fee amounting to Rs.500 (Non Refundable) in the shape of pay order in favor of UCG Project Thar, Islamkot. Tender documents can also be obtained through email by submitting scanned copy of Bank Draft/ Pay Order however its original should accompany the tender otherwise bid will not be considered. Bids received through email can be automatically rejected.
- 03. Submission of Tender Documents: The tenders will be received back up to <u>27-02-2015</u> at 1100 Hrs and will be opened on the same day at 1200 Hrs at UCG Thar Project Site BhambneoBheel, IslamkotMithi District Tharparkar in the presence of Procurement Committee and the bidders or their authorized representatives who may be present.
- **04.** Eligibility: Valid Registration with tax authorities & Valid Dealership/ Stockist/ Supplier Certificates.
- 05. Method of Procurement: Single Stage Single Envelope.
- 06. Terms & Conditions.
 - a) Sample of stitched cover cloth can be inspected at the UCG Site.
 - b) Stitching as per instructions by Engineer In charge.
 - c) Rate should be per Sq Mtr
 - d) Responsive Bidder is required to submit following documents with bid:
 - (i) Valid Registration with tax authorities & Valid Manufacturing/ Dealership/ Stockist/ Supplier Certificates;
 - (ii) Affidavit that firm has never been black listed;
 - (iii) Inspection will be done at Suppliers' premises.
 - e) Under following conditions bid will berejected:-
 - (i) Conditional and telegraphic bids/tenders;
 - (ii) Bids not accompanied by bid security of required amount, Tender Form, and documents mentioned in para (a);

- (iii) Bids received after specified date and time.
- (iv) Firms black listed by any Department of Govt. of Sindh/ Govt. of Pakistan.
- f) Bid validity Period: (90) days.
- g) Bid Security amounting to 2% of Bid Price should be submitted along with the Bid in shape of Pay Order in favor of Accounts Officer, UCG Thar Project, issued by any scheduled Bank of Pakistan.
- h) The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.
- i) Amount of the tender is below Rs.1 Million.
- j) Delivery time will be 20 days after the date of receipt of supply order.
- k) GST/Income Tax Exemption Certificates, as the case may be, must be accompanied with the tender.
