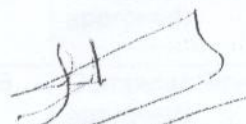
5. The comparative position of above 1st Lowest tender's amount with the estimated amount as per approved PC-II is as follows:-

Above position shows that above rates for the items of Section-1, Section-2-B and Section-3 are 241.50%, 167.38% and 86.29% above respectively against the approved PC-II cost which seem to be on very higher side and will not serve the purpose of acquiring the (value for money) as per SPPRA Rules 2010.

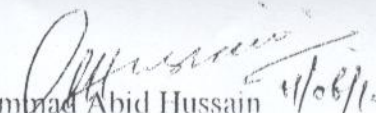

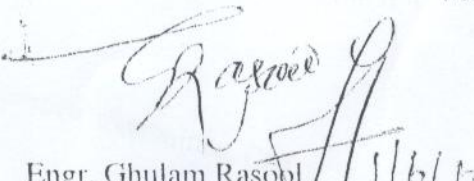
8. In view of the position at Para-6&7, the committee has recommends that tenders be rejected and to be re-invited in accordance with SPPRA Rules 2010.
