

Subject: GUIDELINES ON NOTICE INVITING TENDER (NIT)

It has been observed during the assessment of documents uploaded by the Procuring Agencies on SPPRA-PPMS Website and during the proceedings of Review Committee that Procuring Agencies do not prepare Notice Inviting Tenders (NITs) in accordance with the standard format of the NIT as provided in the SPPRA Guidelines / Regulations for Procurement of Works notified by the Authority under Section 27 of the SPP Act, 2009 (Annexure-I).

2. It has further been observed that Procuring Agencies do not open the bids as per the schedule of opening of bids mentioned in the NIT and Bidding Documents and postpone the bid opening to 2nd attempt provided in the NIT without any intimation to the Authority and bidders which is against the fairness and transparency. It is clarified that 2nd attempt schedule provided in NIT is for "Un-responded Tenders" only, i.e. in case a procuring agency does not receive any bid in response to the NIT or any item of the NIT till



the deadline of submission of bids. Provided that the Procuring Agency shall upload the "Corrigendum" for adoption of 2nd attempt on the SPPRA Website and Procuring Agency's own website, if exists, otherwise the procurement process has got to be declared as misprocurement under Rule-32(A) of SPP Rules, 2010.


In view of the above, it is requested that all the procuring agencies under your administrative control may please be directed to ensure compliance of the above instructions in letter and spirit in order to avoid procurement violative of the rules.
