## SUBJECT: COMPLIANCE OF SPP RULES 2010 - RELEASE OF 'SPPRA-ID'

As per the current policy of the Sindh Public Procurement Regulatory Authority (SPPRA), IDs of the NIT / EOI are released after receipt of the Bid Evaluation Report in terms of Rule-45 of SPP Rules, 2010.

- 2. The SPPRA has decided to change the policy regarding release of 'SPPRA-ID' with effect from 1<sup>st</sup> July, 2013. The SPPRA will release 'SPPRA-ID' to the procuring agencies (PAs), once PAs submit the following documents, complete in all respect, as required under the rules:
  - (i) Annual Procurement Plan as required under Rule-11 of SPP Rules 2010.
  - (ii) Notice Inviting Tender, Expression of Interest (EOI) and Pre-qualification Notice. (Requirement of Rule-17)
  - (iii) Bid Evaluation Reports. (Prescribed by Rule-45)
  - (iv) Contract Evaluation Form along with Letter of Award, Form of Contract (Agreement) and Bill of Quantities. (Requirement of Rule-50)
  - (v) Integrity Pacts (where applicable) (Requirement of Rule-89)
- 3. However, it is clarified that the hoisting of NITs / EOIs / BERs and other related documents on Authority's website and the release of 'SPPRA-ID' does not deemed to imply that Authority certifies the contents of the documents, propriety of procurement process and quality



of procured goods, works and services as the responsibility for ensuring proprietary of the procurement process and the quality of procurement rests with the procuring agency concerned.

 All the procuring agencies under your administrative control may therefore be intimated accordingly.
