## SUBJECT: NIT(s) HOISTING CHARGES - CLEARANCE OF OUTSTANDING DUES

Rule-17 of Sindh Public Procurement Rules 2010 stipulates that all Procurements over one hundred thousand rupees shall be advertised by timely notifications on the Authority's website

- 2. In pursuance of decision of the SPPRA Board of Directors, a fee of Rs. 1,000/- was charged on each NIT uploaded on SPPRA Website w.e.f. 01.10.2010 and subsequently with the approval of the Board this has been revised to Rs. 2,000/- w.e.f. 01.07.2012.
- However, it has been observed that majority of the procuring agencies are not depositing the prescribed fee.
- It is, therefore, requested that the procuring agencies under your administrative control may please be directed to clear the outstanding dues of SPPRA for uploading the NIT(s) latest by 30<sup>th</sup> June, 2013. For future, the procuring agencies may be advised to submit the uploading fee @ Rs. 2,000/- per NIT along with the NIT.
