SUBJECT: DETAILS OF PUBLIC PROCUREMENTS DURING THE FINANCIAL YEAR 2009-2015.

Kindly refer to this Authority's letter No. Dir(A&F)/SPPRA/Mng(Vigilance)/15-16/8875 dated 15th December, 2015 on the subject.

2. Sindh Public Procurement Regulatory Authority in coordination with Finance Department is in the process of compiling annual reports, which is a mandatory requirement under Section-17 of Sindh Public Procurement (SPP) Act, 2009.
3. It has been observed that various procuring agencies are not complying the SPP Rules, 2010 (Amended-2013) in their public procurements, where, government funds are involved. Such procurements amounts to statutory violations. Transparency International Pakistan, National Accountability Bureau & other agencies have also pointed such discrepancies.
4. It is, therefore, once again requested that procuring agencies under your administrative control may be directed to furnish the information regarding the procurements undertaken from the financial year 2009 to 2015 (year-wise) as per proforma at **Annexure**. You are further requested to strictly direct the Authorities, NGOs, partner organizations and Independent bodies working directly under your control or otherwise to comply SPP Rules in the procurement process, where even a single penny of public fund is involved or utilized.
