SUBJECT: COMPLIANCE OF SPP RULES 2010 – PUBLICATION OF ADVERTISEMENTS IN ENGLISH, URDU AND SINDHI LANGUAGES

I am directed to invite your attention towards **Rule 17(2)** of Sindh Public Procurement Rules 2010 (amended 2013) which stipulates as under;

"The advertisement in the newspapers shall appear in at least three widely circulated leading dailies of English, Urdu and Sindhi languages"

2. It has been observed that, some Procuring Agencies publish NITs / EOIs in English, Urdu and Sindhi newspapers in English language only instead of the respective language of newspaper i.e. Urdu and Sindhi which is against the spirit of the above said Rule.
3. It is, therefore, requested that the Procuring Agencies under your administrative control may please be directed to ensure the publication of NITs / EOIs three **leading and widely circulated newspapers** in English, Urdu and Sindhi in respective languages instead of English language only.
