## SUBJECT: VISIT OF AUTHORIZED OFFICIALS TO SPPRA OFFICE

This Authority has so far issued user ID and Password to authorized personnel of over 500 procuring agencies of the province in order to enable them to upload / host procurement related documents directly on Authority's website through newly launched PPMS. This user ID / Password is supposed to be kept safe, secure and confidential so as to maintain the integrity of the system.

- 2. The SPPRA team is always available during working hours to assist the visiting officials of PA's or to provide guidance over telephone. However, it has been observed that certain procuring agencies, while facing technical issues or require SPPRA's assistance, are sending private persons / bidders to SPPRA office along with user ID / password issued to the authorized personnel, which tantamounts to compromising on the security of confidential information.
- 3. In view of the above, it has been decided that this Authority will henceforth entertain for assistance only authorized personnel, upon presenting authorization letter duly signed by the Head of Procuring Agency.
