

No. <u>SORI(SGA&CD)2-30/2010</u>:- In exercise of the powers conferred by Section 26 of the Sindh Public Procurement Act, 2009, the Government of Sindh are pleased to make the following amendments in the Sindh Public Procurement Rules, 2010:-

### **AMENDMENTS**

- 1. In rule 15-A -
  - after the words "one thousand million rupees and above" the words "except for Public Private Partnership Projects which may be of any cost" shall be inserted;
- ii. in clause (e), after the words "lowest bidder" the words' or in case of Public Private Partnership Projects "best evaluated bidder" shall be inserted;
- iii. the existing rule shall be renumbered as rule 15-A(1) and thereafter the following new sub-rules shall be added:-
  - "(2) This rule shall apply to all projects including Public Private Partnership Projects.
  - (3) In case of Public Private Partnership Projects, all other Rules as prescribed in Part-IV of SPP Rules, 2010 shall be applicable".
- 2. Rule 86 shall be deleted.
