## BID EVALUATION REPORT IN PURSUANCE OF RULE-45 OF SINDH SUBJECT: PUBLIC PROCUREMENT RULES, 2010.

- It has been observed that most of the procuring agencies are not 1. forwarding the Bid Evaluation Reports relating to the public procurements for examination and hoisting on SPPRA website. The matter was discussed in the 14th meeting of the SPPRA Board held under the Chairmanship of Minister for Law, Parliamentary Affairs & Criminal Prosecution Service, Government of Sindh and it was resolved that the Bid Evaluation Reports must be hoisted on the website of the Authority seven days prior to the Award as required under Rulr-45 of Sindh Public Procurement (SPP) Rules, 2010, failing which the such cases shall be referred to the Heads of the Procuring Agencies for initiating cases against the officer(s) violating the Rule under appropriate law.
- Rule-45 of the SPP Rules, 2010 stipulates that procuring agencies shall announce the results of bid evaluation in the form of a report giving reasons for acceptance or rejection of bids. The report shall be hoisted on website of the Authority and that of the procuring agency if its website exists and intimated to all the bidders at least seven (07) days prior to the award of contract.
