



PROCUREMENT OFFICIALS CERTIFIED (DISBURSEMENT LINK INDICATOR), SINDH PUBLIC SECTOR MANAGEMENT REFORM PROJECT (SPSMRP).

Government of Sindh have decided that all the Procuring Agencies shall carry out procurements through officers/officials possessing mandatory certified training of procurement to be conducted through Sindh Public Procurement Regulatory Authority.

The training schedule shall be circulated by the SPPRA in due course of time. All the Procuring Agencies shall enroll officers/officials involved in procurements for the said mandatory training. The Procuring Agencies under the Government of Sindh shall reconstitute Procurement Committees/Consultant Selection Committees comprising only certified/trained officers/officials. This shall take effect from 1st November, 2017.


