SUBJECT: COMPLIANCE OF SINDH PUBLIC PROCUREMENT RULES, 2010

It is noted with concern that some Procuring Agencies are issuing 'Notice Inviting Tender' to only favourite prequalified bidders in violation of Rule-28(1)(C) of SPP Rules, 2010, which stipulates as under:

Rule-28(1)(c)

All applicants found capable of carrying out the assignments in accordance with the approved prequalification criteria shall be prequalified and <u>invited to submit bids.</u>

It is, therefore, requested that Procuring Agencies under your administrative control may be advised to publish 'Notice Inviting Tender', issued to all prequalified bidders, in three widely circulated leading dailies of English, Urdu and Sindh languages as well as posting/hoisting on the SPPRA's website in the larger interest of transparent procurement under intimation to this Authority.
