Subject: **HOISTING OF TENDERS ON SPPRA WEBSITE.**

As the procuring agencies are very well aware that Rule-12 of the Public Procurement Rules 2004 makes it mandatory on all the procuring agencies to hoist the Notices Inviting Tenders (NITs) / Expressions of Interest (EOIs) exceeding Rs: One Hundred Thousand on the Authority's Website.

2. It is, however, observed that many procuring agencies are still not complying with the above mandatory stipulation of the Rules. As a consequence, their NITs are neither being examined by the Authority nor are they being assigned the SPPRA ID. (Please visit www.pprasindh.gov.pk for locating the SPPRA ID assigned to the NITs/EOIs).

3. In view of aforesaid, the procuring agencies are advised to ensure that the provisions of Rule- 12 are compiled with in letter & spirit. It is further stated that in case the procurements initiated after 15th

February 2010, are not forwarded to the Authority and as a consequence whereof the SPPRA ID is not assigned, the Authority would be constrained to request the office of Accountant General, Sindh to stop all payments concerning such procurements.
