SUBJECT: COMPLIANCE OF SPP RULES 2010 - STANDARD BIDDING DOCUMENTS

In continuation of this Authority's letters of even number dated 21.12.2011, 20.04.2012, 18.10.2012 and 09.01.2013 (copies enclosed), I am directed to say that despite repeated reminders and instructions most of the procuring agencies are still not using the notified Standard Bidding Documents (SBDs) for Procurement of Works (Small, Medium and Large) as explicitly stipulated in Rule-(21)(3) of Sindh Public Procurement (SPP) Rules, 2010.

It is, therefore, requested that procuring agencies under your administrative control may be directed to ensure the use of notified Standard Bidding Documents. It may also be noted that the noncompliance of mandatory provisions of Rule-(21)(3) of SPP Rules, 2010 may render the procurement process a "mis-procurement" in terms of Rule-56 of SPP Rules, 2010.
