Subject: POSTING/ HOISTING OF DOCUMENTS ON PPMS-SPPRA WEBSITE

I am directed to refer to the subject noted above and to state that Rule-45 of the SPP Rules, 2010 requires hoisting of Bid Evaluation Report at least three working days prior to Award of Contract and Rule-50 stipulates that within fifteen (15) days of signing of contract, procuring agency shall publish contract documents on the website of the Authority. The Rules are reproduced below:

Rule-45 Announcement of Evaluation Reports – Procuring agencies shall announce the results of bid evaluation in the form of a report giving reasons for acceptance or rejection of bids. The report shall be hoisted on website of the Authority and that of the procuring agency if its website exists and intimated to all the bidders at least three (3) working days prior to the award of contract.

Rule-50 Publication of the Award of Contract -Within fifteen (15) days of signing of contract, procuring agency shall publish on the website of the Authority and its own website, if such a website exists, the results of the bidding process, identifying the bid through procurement identifying number, if any, and the following information;

- (1) Contract Evaluation Report;
- (2) Form of Contract and Letter of Award;
- (3) Bill of Quantities or Schedule of Requirement.

2. However, it has been observed that most of Procuring Agencies have not uploaded Bid Evaluation Reports and Contract Documents of the schemes/items on PPMS-SPPRA website as required under SPP Rules, 2010.

3. It is therefore, requested that the procuring agencies under your administrative control be directed to post/upload/hoist bid evaluation report and contract documents against schemes/works/items etc posted on PPMS-SPPRA website. In case the scheme(s)/item(s) have been cancelled by Procuring Agencies, such information shall also be uploaded on the PPMS website in order to avoid mis-procurement at later stage.
