#### Proceedings of the Review Committee:-

- i. The Review Committee was informed that the appellant was called for the maintainability of their appeal. The committee was informed that the appellant was served with notice and letter was also sent to him on whats-app number. He received the letter but did not appear before the Review Committee for the hearing of his appeal.
- ii. The Review Committee decided to decide the appeals Ex-parte.
- iii. The Committee was informed that these appeals had been listed for maintainability in terms of Rule 31(5) as the appellants approached to the Review Committee after 23 days instead of 10 days as per SPP Rules.
- iv. The Committee was informed that the Appellant filed the complaints on 11.1.2023.CRC failed to decide within 7 days and appeals transferred to the Review Committee on 18.01.2023.The appellant was required to approach the Review Committee till 28.01.2023.The Appeal period expired on 28.01.2023.The Appellant approached to the Review Committee on 10.02.2023 after the lapse of 23 days of the transfer of the complaint.

#### Observation of the Review Committee:-

The Review Committee observed that the SPP Rules have described time limit for complaint redressal mechanism. In case of transfer of appeal due to failure of CRC to decide the matter within 7 days, the complainants are required to approach to the Review Committee within 10 days of transfer.

#### Rule 31 (5) of the SPP Rules is reproduced as under:-

- (5) The complaint redressal committee shall announce its decision within seven days and intimate the same to the bidder and the Authority within three working days. If the committee fails to arrive at the decision within seven days, the complaint shall stand transferred to the Review Committee which shall dispose of the complaint in accordance with the procedure laid down in rule 32.]
- ii. In the instant matter the appellants could not approach the Review Committee within ten days of transfer but instead approached after laps of 23 days. The matter is summarized as below:-
