Reason for delay	Due to completion of tenure of two Private Members from SPPRA Board the Review Committee was incomplete, hence meetings were not conveyed. Now the Board has nominated Members for RC under Rule-32(3) of the SPP Rules, 2010 and accordingly the meeting of the Committee was conveyed to dispose of the Review Appeal.

**Appellant's Version:-**

- i. The appellant was called for the meeting of the Review Committee but he did not appear before the Review Committee. The Review Committee decided to adjudicate the matter ex-parte.
- ii. The Review committee was informed that the appellant had withdrawn his bid security and appeal, as the appeal could not be considered decided within 10 days.

**Observations of the Review Committee:-**

- iii. The Review Committee observed that the appellant had withdrawn his Bid Security. Therefore, his appeal cannot be considered by the Review Committee in terms of Rule 32(1) of the SPP Rules which is as under



**Rule 32(1) of the SPP Rules**

- (1) A bidder not satisfied with decision of the procuring agency's complaints redressal committee may lodge an appeal to the Review Committee [within ten (10) days of announcement of the decision]' provided that he has not withdrawn the bid security, if any, deposited by him

**Decision of the Review Committee:-**


- i. Given proceeding, findings, observations and due deliberations, the Review Committee decided to file the appeal as the appellant has withdrawn his appeal and bid security.
