Introduction:

- The Executive Engineer Provincial Highways Division Sukkur "The Procuring Agency" invited bids for procurement of various works including vide NIT No. TC/G-55/514/ dated 10.3.2023 in Newspapers and also hoisted on SPPRA Website vide Serial No. T00588-22-0002,
- The appellant applied for works No. Or applied work No 8 Procurement Committee opened the bids on 04.03.2023. The appellant kept waiting but the procuring agency did not announce the bid Evaluation Report till 28,4,2023.
- The Appellant approached to CRC on 28,04,2023 with request to look into the malafide intentions of the procuring agency.
- 4. The CRC failed to decide the matter within 7 days. Therefore, the appellant submitted a Review Appeal before the Review Committee on 10.05.2023 with a request to direct the procuring agency and procurement committee of XEN Highways Division Sukkur to stop the procurement process till the final decision of the Review Committee.
- Accordingly, the appeal of the appellant was listed before the Review Committee for hearing on 01.06.2023 and the appellant was informed vide letter dated 26.5.2023.

2. Proceedings of the Meeting:

6. The Chair welcomed the participants and asked about the appellant. The Review Committee were informed that the appellant failed to appear before the Review Committee. Furthermore, the Review Committee was informed that the appellant has withdrawn his Review Appeal vide letter dated 31.05.223 that was submitted on 1.6.2023 on the date of hearing of the appeal of the appellant.

3. Observations of the Review Committee

 The Review Committee observed that the behavior of the appellant towards his appeal showed that he had filed the frivolous appeal as he has not pursue his appeal seriously. 6 Hrs





- 8. The Committee noted that submission of frivolous Review Appeals is not only hampering smooth working of the Authority but also causing huge losses of time and resources to the exchequer.
- 9. The Review Committee is of the unanimous opinion that the appellant has filed this review appeal to misuse the forum of the Review Committee for ulterior motives.

Decision of the Review Committee

Given the proceedings findings/observations and after due deliberation, the Review Committee, in exercise of powers conferred upon it under Rule 32(7) of SPP Rules has decided as under;

- 1. Dismiss the instant Review Appeals being frivolous.
- 2. Directed the Procuring Agency to forfeit the bid security submitted by the appellant.
- 3. Impose a penalty on the Appellant an amount equivalent to ten times of the amount paid as Review Appeal fees. The appellant is directed to pay amount of penalty of Rs.200,000/- (Two Hundred Thousand only) in shape of Pay Order in favor of SPPRA within 15 days from the issuance of this decision failing which no Review Appeal shall be considered in

future.
