1. Introduction:

- 1.1 The Executive Engineer Public Health Engineering Division-1, PHED Department Khairpur "The Procuring Agency" invited bids for procurement of various works vide NIT No. TC/3180 dated 27.5.2022 in Newspapers and also hoisted on SPPRA Website vide NIT Serial No. T00692-21-0008.
- 1.2 The Appellant submitted that the officials of procuring agency took away the bids but did not open the bids .
- 1.3 The Appellant approached to CRC on 13.06.2023 with a request to look into the malafide intentions of the procuring agency and restrain the Procuring Agency from awarding the contract.
- 1.4 The CRC failed to decide the matter within 7 days. Therefore, the appellant submitted a Review Appeal before the Review Committee on 20.06.2022 with a request to decide the matter within best interest of justice.
- 1.5 The appeal of the appellant was listed for hearing before the Review Committee on 20th July 2023. The appellant was informed vide letter date17th July 2023.

2. Proceedings of the Meeting:

2.1 The Chair welcomed the participants. The Review Committee was informed that the appellant failed to appear before the Review Committee despite service of notices.
