Decision of the Review Committee under Rule-32 of the SPP Rules, 2010 held on 20.07.2023

1. Introduction:

- 1.1 The Chief Administrator Auquaf Sindh, Hyderabad "The Procuring Agency" invited bids for procurement of various works vide NIT No No.AUQF(CAA)TENDER/1498 dated: 29-03-2023 in Newspapers and also hoisted on SPPRA Website vide Serial No. T01324-22-0008
- 1.2 The appellant applied for works No. 3, 4 & 8. Procurement Committee opened the bids on 28.04.2023 The Appellant submitted that the procuring agency did not inform him about the financial opening of bids. The Appellant approached to CRC on 18.05.2023 with a request to look into the malafide intentions of the procuring agency and restrain the Procuring Agency from awarding the contract. The CRC failed to decide the matter within 7 days.
- 1.3Therefore, the appellant submitted a Review Appeal before the Review Committee on 29.05.2023 with a request to decide the matter within best interest of justice. The appeal of the appellant was listed for hearing before the Review Committee twice on 13th July and 20th July 2023.

2. Proceedings of the Meeting:

2.1 The Chair welcomed the participants. The Review Committee was informed that the appellant failed to appear before the Review Committee twice on 13th July 2023 and 20th July, despite the service of notices of the meeting sent to him wherein he was advised to appear before the Review Committee.

3. Observations of the Review Committee:

3.1. The Review Committee observed that the behavior of the appellant towards his appeal showed that he had filed frivolous appeal as he had not pursued his appeal seriously.

- 3.2. The Committee noted that submission of frivolous Review Appeal is not only hampering smooth working of the Authority but also causing huge loss of time and resources to the exchequer.
- 3.3. The Review Committee observed that the appellant has filed this review appeal to misuse the forum of the Review Committee for ulterior motives.

4. Decision of the Review Committee:

The Review Committee after due deliberation, Dismiss Review Appeals being frivolous, and also Impose a penalty on the appellant an amount equivalent to ten times of the amount paid as Review Appeal fees. The appellant is directed to pay an amount of Rs.200,000/- (Rupees Two Hundred Thousand only) as penalty in shape of Pay Order in favour of SPPRA within 15 days from the issuance of this decision failing which no Review Appeal of the appellant shall be heard
