**1. Introduction:**

1.1. The Executive Engineer, Public Health Engineering Division-I Khairpur "The Procuring Agency" invited bids for procurement of various works vide NIT No. TC/G-2925/855/2022 dated 07.04.2022 through publication in Newspapers and also hoisted on SPPRA Website vide Serial No. T00692-21- 0004. The Method of Procurement was Single Stage Two Envelope.

1.2 The appellant submitted a complaint to the Compliant Redressal Committee of the procuring agency on 13.6.2022. However meeting of the CRC was not convened within the stipulated time period provided in the Rules.

1.3 The appellant submitted a Review Appeal before the Review Committee on 24.06.2022 vide letter No.MA/KHR/45/22 dated 24.06.2022.


**2. Proceedings of the Meeting:**

### **3. Decision of the Review Committee**




