**Decision of the Review Committee under Rule-32 of the SPP Rules, 2010 held**

**on 20.07.2023**

**M/S DBK Enterprises..... The Appellant**

**V/S**

**1. Introduction:**

- 1.1 The Executive Engineer, Highways Division Sukkur “The Procuring Agency” invited bids for procurement of various works vide NIT Reference NO.EE/HW-D/TC/126 dated 05.04.2022 in Newspapers and also hoisted on SPPRA Website vide Serial No. T01698-21-0002.
- 1.2 The appellant participated in the procurement process. The Procurement Committee opened the bids on 12.05.2022.
- 1.3 The Appellant approached to CRC on 09.06.2022 and complained to the Complaint Redressal Committee.
- 1.4 The CRC failed to decide the matter within 7 days. Therefore, the appellant submitted a Review Appeal before the Review Committee on 28.06.2022 vide letter dated 18.06.2022 with a request to place the matter in the Review Committee.
- 1.5 The appeal of the appellant was listed for hearing before the Review Committee on 20<sup>th</sup> July 2023. The appellant was informed vide letter dated 18<sup>th</sup> July 2023.

**2. Proceedings of the Committee:**

- 2.1 The Chair welcomed the participants. The Review Committee was informed that the appellant failed to appear before the Review Committee. Furthermore, the Review Committee was informed that the appeal of the appellant was listed to check the maintainability of the appeal, as the appellant failed to approach to the Review Committee within ten days of transfer of the complaint in terms of Rule 31(5) of the SPP Rules.

### 3. Observations of the Review Committee

The Review Committee observed that the appeal is not maintainable. The appellant approached to CRC on 09.06.2022. The CRC failed to decide the complaint within 7 days, so the complaint stood transferred to the Review Committee on 16.6.2022. The appellant was required to approach to the Review Committee till 26.6.2022 but the appellant approached on 28.6.2022 which is not permissible under the SPP Rules 2010.

### 4. Decision of the Review Committee

The Review Committee after due deliberation, **dismiss** the instant Review Appeal as the complainant failed to submit Review Appeal within stipulated time in accordance with the Rule 31(5) of the SPP Rules 2010.






