**Decision of the Review Committee under Rule-32 of the SPP Rules, 2010 held
on 20.07.2023**

M/s Abra Construction Company The Appellant

V/S

1. Introduction:

- 1.1 The Executive Engineer, Provincial Highways Division, Larkana "The Procuring Agency" invited bids for procurement of various works vide NIT No. TC/G-55/855/2022 dated 13.05.2022 through publication in Newspapers and also hoisted on SPPRA Website vide Serial No. T00786-21- 0006. The method of Procurement was Single Stage Two Envelope.
- 1.2 The appellant submitted a complaint to the Complaint Redressal Committee of the procuring agency on 11.6.2022. However the meeting of CRC was not convened within the stipulated time period provided in the Rules.
- 1.3 The appellant submitted a Review Appeal before the Review Committee on 21.06.2022 vide letter No.RC/PHWLRK/22/03 dated 20.06.2022

2. Proceedings of the Meeting:

The Chair welcomed the participants. The Review Committee was informed that the appeal was listed for hearing in order to check the maintainability of the appeal in terms of Rule 32(5) of the SPP Rules 2010 as the appellant did not mention the work for which he applied and nor mentioned that whether he dropped the bids alongwith bid security in tender box or otherwise, The Review Committee was also informed that the appellant failed to appear before the Review Committee despite the service of the notice.

3. Observations of the Review Committee:

3.1 The Review Committee observed that the appellant submitted incomplete documents with Review Appeal. Rule 32(5) requires that appellant shall submit following documents to the Review Committee;

(a) a letter stating his wish to appeal to the Review Committee and the nature of complaint;

(b) a copy of the complaint earlier submitted to the complaint redressal committee of the Department and all supporting documents;

(c) Copy of the decision of Procuring Agency Complaint Redressal Committee if announce.


3.2 The Committee noted that that the appellant did not state the nature of complaint clearly in his appeal and also did not mentioned the work for which he applied. It was further discussed that it is not clear from the appeal that whether he has submitted his bid or not to the procuring agency.

4. Decision of the Review Committee

Given the proceedings findings/observations and after due deliberation, the Review Committee, **dismiss** the instant Review Appeal as the appellant has not pursued his appeal nor he is clear about the complaint.


