1. Introduction:

- 1.1 The Executive Engineer, Rohri Division, Moro "The Procuring Agency" invited bids for procurement of various works vide NIT Reference NO. SKP/G-66/1311 DATED 18.05.2022 in Newspapers and also hoisted on SPPRA Website vide Serial No. T01517-21-0010.
- 1.2 The appellant participated in the procurement process. The Procurement Committee opened the bids on 10.06.2022.
- 1.3 The Appellant approached to CRC on 29.06.2022.
- 1.4 The CRC failed to decide the matter within 7 days. Therefore, the appellant submitted a Review Appeal before the Review Committee on 19.07.2022 vide letter dated 19.07.2022 with a request to place the matter before the Review Committee.
- 1.5 The appeal of the appellant was listed for hearing before the Review Committee on 20th July 2023. The appellant was informed vide letter dated 18th July 2023.

2. Proceedings of the Meeting of the Review Committee:

2.1 The Chair welcomed the participants. The Review Committee was informed that the appellant failed to appear before the Review Committee. Furthermore, the Review Committee was informed that the appeal of the appellant was listed to check the maintainability of the appeal, as the appellant failed to approach to the Review Committee within ten days of transfer of the complaint in terms of Rule 31(5) of the SPP Rules.

3. Observations of the Review Committee

3.1 The Review Committee observed that the appeal is not maintainable. The appellant approached to CRC on 29.6.2022. The CRC failed to decide the matter within 7 days, accordingly the complaint stood transferred to the Review Committee on 6.7.2022 as per Rules 31(5) .the appellant was required to approach to the Review Committee within 10 days of such transfer i.e up to 16.7.2022 in terms of Rule 31(5). However, the appellant approached to the Review Committee on 19.07.2022 i.e after 13 days of the transfer of the complaint.

4. Decision of the Review Committee

4.1 Given the proceedings, findings/observations and after due deliberation, the Review Committee, in exercise of powers conferred upon it under Rule 32(7) of SPP Rules dismiss the appeal of the appellant as the appellant failed to approach the Review Committee within stipulated time mentioned under Rule 31(J) of the SPP Rules 2010.
