1. Introduction:

- 1.1 The Executive Engineer, Northern Division, Irrigation Dadu "The Procuring Agency" invited bids for procurement of various works vide SKP/G-66/1127 dated: 27.06.2022 through publication ⁱⁿ Newspapers and also hoisted on SPPRA Website vide Serial No. T00871-22-0002. The method of Procurement was Single Stage one Envelope.
- 1.2 The appellant submitted a complaint to the Compliant Redressal Committee of the procuring agency on 11.08.2022 however the meeting of CRC was not convened within the stipulated time period provided in the Rules.
- 1.3 The appellant therefore submitted a Review Appeal before the Review Committee on 22.08.2022 ref AR/513 dated 19.08.2022 under Rule 31(5) of the SPP Rules 2010

2. Proceedings of the Meeting:

- 2.1 The Chair welcomed the participants. The Review Committee was informed that the appellant vide letter No. ARC/542 dated 19.07.2023 has stated that the validity of M&R program has expired in June, 2023 therefore; the appellant does not want to proceed further.

3. **Decision of the Review Committee**

The Review Committee, after due deliberation, **Dismiss** the instant Review Appeal as the appellant does not want to proceed in the matter and has withdrawn his Review Appeal.


