APPEAL BEFORE THE REVIEW COMMITTEE UNDER RULE-32 OF SPP RULES, 2010, AGAINST PROCURING AGENCY MUNICIPAL COMMITTEE TANDO ADAM – REQUEST FOR CANCELLATION OF BID EVALUATION REPORT OF NIT ID T00687-19-0006 REFERENCE NO.ME/373 OF 2020 DATED 12.06.2020.

The undersigned is directed to refer to your appeal preferred to vide letter dated 13<sup>th</sup> July 2020, on the subject cited above, whereby you made a request to this Authority for considering/ placing the case before the Review Committee on account of the procuring agency's (complaints redressal committee) failure to redress your grievances within the specified time as provided under Rule-31(5) read with Rule-32 of SPP Rules, 2010.

- 2. Accordingly, your case after conducting initial scrutiny, was processed/considered for hearing and further decision in the Authority's Review Committee meeting that was scheduled on  $11^{th}$  August 2020 at 12.00 p.m. and notice, in this regard, was served vide this Authority's letter of even number dated  $06^{th}$  August 2020, to the procuring agency as well as your firm to appear on the given schedule along with relevant record to contest the case.
- 3. In compliance, the procuring agency's representatives Mr. Asghar Ali Abbasi (Chairman) and Mr. Asif Ali (Council Officer) appeared before the Review Committee; whereas, there was no representation from your side. The procuring agency's representatives confirmed that the CRC convened its meeting on 10<sup>th</sup> July 2020 for redressal of aggrieved bidders' grievances and subsequently announced/ circulated its decision vide letter No.ME/395/2020 dated 16<sup>th</sup> July 2020 that can also be accessed via the Authority's website i.e. http://www.pprasindh.gov.pk/committee/84CRCMCTandoadam27072020.PDF.
- The Review Committee members took a serious note on your absence without any intimation despite the fact you had been served a written notice as well as verbal reminders to ensure appearance on the scheduled date and time in terms of Rule-32(8) of SPP Rules, 2010. Due to such apathy and nonchalant attitude from your side, the Review Committee decided to reject the reference in terms of Rule-32(7)(a) of SPP Rules, 2010.
