- The matter was listed for hearing before the Review Committee twice. The appellant appeared before the Review Committee on 10.1.2022 but the procuring agency was absent .On the next date of hearing on 20.1.2022, The procuring agency was represented by the Executive Engineer whereas the appellant failed to appear before the Review Committee in its meeting on 20.1.2022. The Review Committee decided to adjudicate the matter ex-parte
- 2. The Review Committee observed that the appellant had filed the frivolous appeal.
- 3. The Committee noted that the problem of frivolous Review appeals is not only hampering smooth and timely working of the Review Committee but also causing huge loss of time resources and also cause harm to many entities, in many ways. The procuring agency against whom the groundless complaint is lodged becomes the source of serious harassment and inconvenience, and in some cases reputation on stake. The Review Committee process itself becomes clogged, disrupted, and delayed, thus affecting the other appellants in general, and becomes source of the undue delay in the disposal. The situation therefore cries out for remedies to avert these harms.

Given the proceedings findings/observations and after due deliberation, the Review Committee, in exercise of powers conferred upon it under Rule 32(7) of SPP Rules declares the instant review appeal frivolous rejects and the Review Committee is of the unanimous opinion that the appellant has filed this review appeal to misuse the forum of the Review Committee for ulterior motives. Therefore, the Review Committee declares that the bid security submitted by the appellant shall be forfeited by the procuring agency. Furthermore, the committee decided to impose a penalty, equivalent to five times of the amount submitted as the Review Appeal fees, on the appellant. The appellant shall submit penalty of Rs50, 000, (Fifty Thousand) to the Authority in the same manner as the Review Appeal fees is submitted within one month.
