This appeal has been preferred by the appellant M/S Green Top Pharma hereinafter referred as "Appellant" in terms of Rule 31(5) against the procuring agency "The Medical Superintendent Ghulam Muhammad Mahar Medical College Hospital Hyderabad." hereinafter referred as the "procuring agency". The appellant was called by the Review Committee for ascertaining the maintainability of appeal. The appellant came to office but did not appear before the Review Committee.
- 2. The Review Committee decided to decide the appeal Ex-parte in terms of the Rule 32(10).

- 3. From the perusal of record, it appears that the appellant had not approached the Complaint Redressal Committee and Review Committee timely. The complainant submitted an application before the Medical Superintendent Ghulam Muhammad Mahar Medical College Hospital Sukkur under Rule 31 of the SPP Rules 2010(amended up-to-date) whereas as per notification, uploaded on PPMS website, the Secretary Health Department was the Chairman of Complaint Redressal Committee. Hence, the complaint failed to approach the Complaint Redressal Committee as per Rule 31 of the SPP Rules.
 - 4. As a matter of fact the Review Committee is a second remedy available under SPP Rules 2010(amended up-to-date). The Review Committee can only be approached if the bidder approaches the Complaint Redressal Committee before approaching the Review Committee of the Authority in terms of Rule 31(5) & 32(1). In the instant matter the appellant had not approached the Complaint Redressal Committee headed by the Secretary Health Department in terms of Rule 31 of the SPP Rule as mentioned above.

Decision of the Review Committee:

Given the proceedings, findings, observations and after due deliberation, in exercise of power conferred by the Rule 32(7)(a) of the SPP Rules, the Review Committee rejects the appeal being is not maintainable in terms of the Rule 31 and 32 of the SPP Rules 2010(amended up-to-date).
