- 8/- Certificate of financial stability from Banks.
- 9/- Annual Audit Reports for 03 years as least.
- 10/- Income Tax paid for the last 03 years along with Certificate.
- 11/- Certificate of Sales Tax. SRB & NTN.
- 12/- An affidavit to the effect that the contractor/firms or any of its partners have not been black listed by the any Government/Semi Government Department.
- 13/- Details of litigations/arbitration cases against the contractor/firms, if any.
- 14/- Any other relevant information.

The pre-qualification documents can be had from the office of the Executive Engineer Provincial Highway Division Sukkur, personally or by mail on the payment of Rs.5000/00 (Non-refundable) on any working day except the day of submission of application from 02/07/2015 to 22/07/2015 and will be submitted on 23/07/2015 12-00 (noon) in the office of the undersigned.

In case of any unforeseen situation resulting in closure of office on the date of submission or if Government declares Holiday the tender shall be submitted on the next working day at the same time & Venue.

The application so far received shall be categorized and pre-qualified according to their Credentials/experience in the relevant fields. The pre-qualified contractors/firms will be invited to bid.

The Procuring Agency reserve the right to reject any or all bids subject to relevant provisions of SPPRA Rule, 2010 (Amended 2013) and may cancel the bidding process at any time prior to the acceptance of a bid or proposal under Rule-25 of said Rules.
