1. The Higher Education Commission (HEC) Islamabad has sponsored the Project Strengthening of Academic Facilities at Shah Abdul Latif University, Khairpur with Scope. Estimated Cost and duration of project are as under:-

The application along with following documents can be obtained from 10-09-2015 and must reach on the address mentioned herein below on or before 12:30 pm on 30-09-2015 and will be open on 01-10-2015 at 12:00 noon in the office of Project Coordinator office at Shah Abdul Latif University Khairpur in front of tender opening/evaluation committee. The prequalified contractors / firms will be invited to bid.
  3. **Eligibility:** Valid Registration with Pakistan Engineering Council in category C-B / C-1 and discipline CE-09 & CE-10 is mandatory;
  4. **Required Documents:** It must include following details/documents:-

- (iii) Income tax return for the last 03 years.

**(G) Any other information. -**

- (i) Details of disputes/litigation or arbitration with client(s).
- (ii) Affidavit that firm has never been black listed.
- (iii) Any other document / information desired by procuring agency.

**5. Evaluation Criteria:**

- (i) Applications with required documents attached shall be evaluated on the score obtained and firms obtaining 70% shall be qualified.
- (ii) Applications of black listed firms shall not be considered;
- (iii) Procuring agency shall disqualify the applicant if, at any time, it finds that the information submitted for qualification was either significantly inaccurate or incomplete.
