The tender documents (Soft Copy of Terms & Conditions and Hard Copy of BOQ/Schedule-B will be issued to the contractor on submission of written request on letter head alongwith original documents with their photo copies as mentioned above and on payment of non-refundable cost of tender price through pay order from any schedule Bank in favor of KMC. Bid Security in shape of pay order from any schedule Bank in favor of KMC as mentioned above should be enclosed with the bid otherwise the tender will be rejected. No tender will be sold on the tender opening date. The terms and conditions of the tender and contract can also be downloaded from web site of KMC (www.karachicity.gov.pk). However the BOQ/Schedule-B shall must be purchased from the above mentioned offices on payment of the prescribed fee and within the specified time.
- In case of any reason, if the tenders are not responded on the above dates the next date of submission and opening will be <u>Dt.</u> 08 / 12 / 2015 and the tender documents will also be available for sale upto <u>Dt.</u> 07 / 12 / 2015.
- 4. In Case the date of opening or last date of sale is declared as a public holiday by the Government, the next official working day shall be deemed to be the date for last date of sale and submission and opening of tenders at the same time as mentioned above.
- The total bid amount as well as the rates of items must be filled both in figures and
 words and in case any correction is made by the contractor himself then each
 correction must be initialed by the Contractor, otherwise the tenders are liable to be
 summarily rejected.
- 6. Substantially Responsive Bid:-
 - Only those bids, which comply with each of the minimum qualification requirements uploaded separately on KMCs' Website and attached with the tender documents shall be declared substantially responsive bids at the time of tender opening and will be eligible for further evaluation, otherwise the same will be declared as non responsive / rejected.
- 7. The bidders are required to submit the above information, the signed evidence against evaluation criteria along with their bids. However Joint Venture between two or more firms is allowed subject to compliance of conditions of stipulated rules of PEC.

- If any fake documents are found then the tender is liable to be rejected/cancelled with out any compensation and with penalty as per rules.
- Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who are reported canvassing will be liable for rejection.
- 10. If a bidder submits a seriously unbalanced bid then he will be required to deposit extra performance security to a level sufficient to protect the procuring agency against financial losses, failing which the submitted bid security will be forfeited by the procuring agency.

 Bid security of the unsuccessful bidder shall be released once the contract has been finalized with the successful bidder or the validity period has expired.
