Bids will be opened at 14 hours on same day before procurement committee in the presence of bidder's representatives who choose to attend at the same address.

- Has completed at least two contracts of De-silting work in Sindh each with a value equivalent to PKR 50 million during last three years i/c satisfactory completion certificates.
- Has an average annual turnover of amount equivalent to PKR 50 million during the last (3) years.
- List of equipment/machinery and qualified staff required in De-silting work available with the firm.
- The under taking / Affidavit on stamp paper by firm /contractor to the effect that neither firms/contractor have ever been black listed / defaulted nor involved in legislation with any Government Department.
- The contractor/firm should be registered with Sindh Revenue Board and other relevant tax authorities.
