

The University of Sindh, Mehran University of Engineering & Technology, Liaquat University of Medical & Health Sciences, Cadet College Petaro and Jamshoro Thermal Power Station are the neighbors of this CNG Station. The Sindh University CNG Station is speared on wider area about more than 50000 Sft with the following equipment facilities.

Single stage – two envelope procedure. Each envelope contain technical & financial proposal separately and shall be marked boldly.

EVALUATION CRITERIA OF TECHNICAL PROPOSAL

- 1. Length of experience of CNG Business or any other business (Proof required).
- 2. Company / firm / individual profile (Proof required).
- 3. Past performance (Proof required).
- 4. Financial position (Bank Balance).
- 5. Managerial capabilities (Details required).
- 6. Bank Statement of last 03 years (Documents evidence required).

FINANCIAL PROPOSAL

On consequent of the evaluation of technical proposal, the financial proposal of eligibility bidders only will be opened by the committee in the presence of bidders or their representatives who wish to be there.

The University of Sindh reserve the right to reject all bids or any one bid as per provision of SPPRA Rules 2010 & amended upto-date.

TERMS AND CONDITIONS FOR CNG STATION RENT PURPOSE

- 1. Conditional tender / quote will not be acceptable.
- 2. Agreement period will be 03 years. Revenue fee of agreement will be paid by renter.
- 3. Advance deposit of 10 months rent shall be paid in the name of University of Sindh in shape of Demand Draft (for successful bidder) before final agreement, which will be refunded after satisfactory completion of agreement period.
- 4. The 10% enhancement of rent will be charged during 2nd & 3rd year of contract agreement.
- 5. The bidder will have to submit Income Tax certificate with NIT.
- 6. Bidder will provide the list of technical manpower / technical staff to be displayed. (The compressor operator must be a trained person from Hydrocarbon Development Institute of Pakistan).
- 7. Successful bidder, after agreement will be bound to pay gas & electricity bills within due dates and provide copy to finance wing, University of Sindh for each successive month.
- 8. After bid evaluation report, the successful bidder will have to sign agreement with University of Sindh on a stamp paper.
- 9. Repair / maintenance of CNG Station including equipments, generator, transformer etc will be made by renter.
- 10. Change of oil of compressor and Generator as required will be made by renter in presence of Sindh University Technical Staff.
- 11. Insurance amount of total CNG will be borne by renter.
- 12. Insurance fee for agreement period should be paid by renter.
- 13. Membership fee of Association and Annual inspection/ license fee will be paid by renter and receipt with documents need to be submitted to the University of Sindh.
- 14. Renter will be responsible for all the damages of equipments and building during contract period. All the maintenance of equipment will be made by the renter.
- 15. Ten 10% enhancement in rent will be charged during 2nd & 3rd year of contract period.
